The undersigned represents that all equipment aboard including, but not limited to, safety and emergency equipment, is properly stowed, has been well maintained, is in good operating condition and is appropriate for this competition. The undersigned also represents that he/she and any crew permitted aboard the yacht are experienced and competent, are physically fit, and capable of swimming and treading water in full sailing attire, and have been instructed in the use and location of all safety equipment aboard the yacht.

The undersigned acknowledges that the decision to start and/or continue racing is the sole and exclusive responsibility of the undersigned. In consideration of the acceptance of this entry, the undersigned certifies that each of the above statements and representations are true and accurate and on behalf of himself/herself and his/her heirs, successors and assigns, hereby release and forever discharges Kollegewidwok Yacht Club and The Northeast Harbor Fleet and their respective members, volunteers, employees, agents, Officers, Board of Directors, Race Committees and Juries from any and all liability arising out of my participation in this regatta and all social events connected there with, whether such loss is due to property damage, personal injury or loss of life, even if such loss or injury is due to the negligence of any party so released.
